Mr. Misra made a presentation on the 'Compliance of Contract Labour Act'. He gave reference to the issues related to contract labour in the Haldia industrial belt of the State. He highlighted that contract labour would be beneficial for the organization, if administered well. Otherwise it would lead to complications. He discussed the main features of the Contract Labour (R & A) Act, 1970 and the vital sections of the Act. He also gave reference to the incorporation of Jamshedpur Utilities and Services Company Ltd (JUSCO).

Mr. Mukherjee spoke on 'Checking of Compliances through online system'. He discussed the digital system followed by TCS to monitor the compliances. He pointed out that Regulatory Compliance is one of the top ten business risks. He mentioned that Scope of HR Compliance involved Employment Laws, Labour Laws and Immigration Laws (in the Regulatory framework) and Ethics, Security and Policies (Non Regulatory framework). He discussed the Global HR Regulatory Compliance Framework of his organization and explained the importance of regular monitoring of Immigration Law. He drew attention of the delegates to the essentiality of educating the executives about the laws of the land, they are operating in.

#### INDEPENDENCE AND THEREAFTER

(Excerpts from "The Bengal Chamber of Commerce and Industry – 1853 -1953 AD Centenary Survey" by Geoffrey Tyson)

#### Continued from earlier edition...

In the result, Mr. Atlee announced on February 2nd, 1947, His Majesty's Government's intention of transferring power to Indian hands, without reservation of any kind, by June 1948, and without regard to whether, by that date, the parties had been able to agree upon a constitution. Lord Mountbatten replaced Lord Wavell as Viceroy, and laid down a time-table for completion of what is historically one of the most

remarkable transactions ever to take place between two nations – the one for so long paramount, and the other hitherto dependent. The rest of the story is familiar and need not be recounted here. Partition was accepted by the parties and by the Indian Independence Act Britain renounced the past and saluted the new independent and sovereign States of India and Pakistan which came into existence on August 15th 1947. The trader and merchant, who in the eighteenth and nineteenth centuries had preceded the civil servant, stayed on after the latter had taken his departure in 1947. The remaining pages of this book are devoted to a brief consideration of the position, the problems and the privileges (for such there are) of this small but important community in the new India.
