Bandhan Financial Services founded and led by Mr. Chandra Shekhar Ghosh, outpaced 23 others including big business houses and renowned names in India Inc. in bagging Reserve Bank of India's recently declared one of two banking licenses.

Mr. Chandra Shekhar Ghosh, 53, Chairman & Managing Director of Bandhan Financial Services, was born in Agartala in Tripura. His father supported the family from the earnings

from his sweet shop. But, he was determined to give a good education to his child. Thanks to the support from his father and his own tenacity, Mr. Ghosh completed his master's degree in Statistics from Dhaka

After completing his studies, he joined an NGO in Bangladesh, BRAC, one of the largest developmental organizations in the world. The interaction with villagers and the poor inspired Mr. Ghosh to work in the sector. He returned to India and worked for several NGOs and dabbled in some business projects as well. His work exposed him to the dire need of money in villages and the massive exploitation by money lenders, who charged 200% to 300% for small loans.

He started Bandhan (which means "Bonding") in 2001 with his personal savings and had two employees. It was a daily challenge for him as he slowly scripted the success story of one of the largest micro-finance

institutions in the country. It began its operations from Bagnan, a small village, 60 km away from Kolkata, and has now spread to 22 States and Union Territories.

Bandhan's micro finance initiative, which today boasts of over 2,000 branches, has built a model with an all-female clientele, zero portfolio risk, and a 100% recovery rate. Bandhan has a total work force of 13,000 employees which reaches out to more than 5.5 million borrowers in the rural areas.

BCC&I along with AIRIA and Capexil organized an Indian Rubber Summit 2014 on 27th March 2014 at the Chamber premises. Young people with deep pockets will drive the Indian market in 2020 but to tap that potential industry needs a strategy to overcome immediate challenges, a panel of experts pointed out at The Bengal Chamber's Conclave on "India as a market in 2020".

The agenda at "India as a market in 2020", organized by the Bengal Chamber of Commerce & Industry in association with The Telegraph and the JIS Group at Williamson Magor Hall on March 29, 2014, was to predict what is going to happen in the next six years and come up with a strategy to meet the emerging needs.

Delivering the Opening Keynote Address, Mr. Richard Rekhy, CEO of KPMG India, put things in a global perspective in his keynote address. "Regulators

are getting smarter as they increasingly begin to understand business... the problem is, rules of globalization were written. But it went too fast and rules did not match the speed of change," said Rekhy." Youth is India's biggest advantage.... They will drive so much consumption," he said. According to Rekhy, the only challenge is lack of adequate stress on education.

"India is to become much more than an IT outsourcing partner. Big pharma companies deploying in India will accelerate.... Innovation is not happening as we do not celebrate failure. We are not building capacities for the future," said Anurag Batra, Chairman, exchange4media Group. Subho Samanta, Group Senior VP, President, SI Global Delivery & SI Emerging Markets, Atos India, stated India held a huge potential for app development.

Sandipan Chakravortty, Managing Director, Tata Steel Processing & Distribution Limited, who moderated the discussion, factually painted India's position and the issues the country faces. About 70 per cent of India's population lives below \$ 2 a day, said Chakravortty. One out of three children suffer from malnutrition, while only 3 per cent of Indians pay income tax.

About 5 per cent of the population control 45 per cent of India's economy. The India of 2020, according to Partha Sinha, Director (India & South Asia), Publicis Group, would need strategic marketing strategies as discretionary income will only come down as inflation becomes a reality.

Summing up the mega trends of 2020, Narayan Devanathan, EVP & National Planning Director, Dentsu India Group, said India would see the middle class bulge, which would lead to a flurry of activities from multinationals.

"We need far more towns around which productive endeavour can grow and be rewarded. The story of the US is that they built roads," said M. Damodaran, the valedictory speaker and former chairman, UTI, IDBI & SEBI.






