In my first message to you after having been elected President of this heritage Chamber, I had spoken about working with the Government of West Bengal towards its endeavour to bring about inclusive growth along with a pro-business environment in the State. As my year-long term comes to an end, it is time to recapitulate. The year has given a fair amount of insight into the areas where the Chamber can meaningfully join forces with the Government with the latter having acknowledged its willingness to engage with the Chamber in areas ranging from Agriculture, MSME, Transportation, Information Technology, Land & Land Reforms initiatives, besides taking part in business and policy reforms.

The Chamber formally opened its office in Siliguri and commenced facilitation services for Industry and Commerce in sync with the vision of our Honb'le CM to promote North Bengal as the gateway to the North East and South East Asia.

During the past one year, apart from amplifying its existing work in the various verticals that it is already engaged in, the Chamber has left its footprints in many new areas and activities like Research and Consulting. To be a bit more specific, I would like to mention here about some work initiated by the Chamber with the Government of West Bengal. The Chamber not only actively participated in BGBS 2016, but on this occasion submitted a paper on the necessary Tax reforms incentives in the State. A reference booklet for the much needed guidance on land and land related matters for the industry was brought out by the Chamber. Also an advocacy report for the support and ease of functioning of the existing SME manufacturing units was brought out.

Initiatives taken up in the realms of Agriculture, Health, Sports Development etc. include the following:

• The Agro and Rural Development Committee visited Santiniketan for a milestone rural development project in villages near Bolpur, conducted seminars on Potato Exports and Farmers Training on Vermicompost Culture in association with Visva Bharati University and Agricultural Training Centre, Narendrapur, Ramakrishna Mission.

- Health related initiatives included signing a Memorandum of Agreement with National Institute of Cholera & Enteric Diseases (NICED) with the sole intent of addressing, bringing to board and undertaking cutting-edge research on those diseases that have assumed or are expected to assume endemic proportions. The Chamber has embarked on a fund raising drive for this research project.
- In the Sporting arena, The Convergence of Sports and Entertainment on the eve of World T20 Final with the Stalwarts of the game gracing the Chamber was an unprecedented occasion.
- The Chamber premises will shortly display Bengal's Industrial heritage and history within the premises in the form of a museum.

The Chamber has also gone much beyond the international borders by taking relevant and prestigious business delegations to South East Asia (Myanmar) and Europe (Italy). Each of these visits opened up new avenues for bilateral relations. Imminent delegations to Sri Lanka and Russia are lined up in October and November respectively. The year also witnessed closer engagement of the Chamber with the US Consulate General through the first ever Select USA roadshow held in Kolkata. As always, the Chamber has strived to improve its services to the membership, industry at large, the Government and the civil society. I am extremely thankful to our members, stakeholders and partners for their valued patronage; to my colleagues and friends in the Managing Committee and Expert Committees, with whom I have had great pleasure of working and co-steering the Chamber ahead during the past one year; to the Secretariat members for their execution, and to the Past Presidents for their support and guidance. My heartfelt thanks to the Honb, le Ministers, Bureaucrats and Government Officials, who have always been kind to us, lent us a patient hearing for all our representations and supported and participated in our activities.

It has been an overwhelming experience and a most memorable one!

#### Women@Work: Greater Scope, Better Pay

The Bengal Chamber of Commerce and Industry along with South Asian Women in Media (SAWM) organized a workshop on "Women at Work" on 20th August 2016.

The purpose of the workshop was to generate media discourse and public discussion on the draft NPW (2016), especially the provisions related to work: skill development, greater career opportunity, higher productivity and greater financial inclusion. It focused on the provisions in the draft for a safe and enabling ambience for working women.

The session was addressed by Dr. Shashi Panja, Hon'ble Minister- of- State, Department of Health and Family Welfare, Women Development & Social Welfare & Child Development, Government of West Bengal, Justice Joymalya Bagchi, Hon'ble Judge, Calcutta High Court and other distinguished and eminent speakers namely Swati Bhattacharjee, General Secretary, South Asian Women in Media (SAWM) India, Dr. Samita Sen, Director, School of Women's Studies, JU, and former Vice Chancellor of Diamond Harbour Women's University, Ms Janet Ford, Deputy Head of Mission, British Deputy High Commission, Smt Suparna Sengupta, COO, Woodlands Hospital, Mr Greg Pardo, Assistant Public Affairs Officer, U S Consulate General, Prof. Arijita Dutta, Professor of Economics, Calcutta University and Ms Ruchira Goswami, Professor of Social Science, NUJS. The session was moderated by Smt Shikha Mukherjee, eminent journalist.

The session discussed the need to bring more women from

the informal economy to the formal economy, so that women have equal opportunity to enter and enjoy decent work, in just and favorable environment. The need is to,

- a. Ensure women's skill development, especially in new and emerging areas like information based industries, telecommunication, software designs, and financial services;
- b. Enhance training and work incentives for women in health and education sectors, which depend heavily on women;
- c. Promote part-time and flexi-time jobs in organized sectors;
- d. Make provisions for re-entry of technically skilled women in job markets, especially after breaks for care giving;
- e. Develop a strategy for the financial sector to reduce gender gap in access to private credit; and
- f. Use technology to reduce drudgery and improve access to health, education, communication.

The workshop was supported by the Department of Health and Family Welfare as well as the Department of Women Development & Social Welfare & Child Development, Government of West Bengal and Ghosh Bose & Associates Pvt. Ltd.

As one of the key focus areas of the International Trade Cell of the Bengal Chamber is to provide advocacy and a networking platform for the EXIM Community and the Government, Mr. Mandal discussed a few issues which are very relevant for the exporters, mainly those who belong to the MSME sector.

Some of the points which Mr. Mandal spoke about, were:

1. With introduction of GST there is uncertainty about whether duty exemption would be available for GST under EPCG & Advance Authorization (AA) scheme. If such exemption is not available, it will act to additional cost for exporters. Though credit would be available, since exports are exempted from taxes, there would be blockage of funds to some extent.

2. Role of Export Inspection Councils - Most of the EIC offices are not situated in manufacturing clusters. This creates problem for inspection & adds to transaction cost. It is therefore requested that manufacturers having ISO certification should be allowed to issue Preferential Certificate of Origin on their own. If need be, selective list of items may continue under EIC.

3. Application for Advance Authorization, EPCG & Duty Credit Scrips should be completely online. Since both the documents E-BRC, & Shipping bill are available online, physical submission of documents should be dispensed with immediately.

4. There is little awareness on the impact of FTAs particularly in MSME sector. There should be a mechanism to sensitize MSME sector in this regard as this is a most vulnerable area. It is pertinent to note that MSMEs' contribution is almost 45 % in exports & hence this should be done as top priority.
