As part of the THINK series, The Bengal Chamber presented Mr. Mike Rann, Premier of South Australia to speak about "South Australia and West Bengal –Towards Collaborative Growth" on 2nd August in association with The Telegraph,

powered by Ballantines.

The Premier spoke about sectors of common interest between South Australia and West Bengal, which would help to generate revenue as well as enhance sustainable growth between the two States.

According to him, South Australia was keen to develop business relations with India, since India, which was the sixteenth biggest trading partner with South Australia till 5 years back, was now on the verge of overtaking US and becoming the second biggest. It was very interesting to note that there were various avenues where the synergy could be worked out well, particularly in sectors like Mining, Education, Tourism, Agriculture, et

South Australia, according to Mr. Rann, was a large province with fertile agricultural land, rich in mineral resources but sparsely populated, which created

an opportunity for Bengal as the number of Indian immigrants had gone up significantly in recent years, and would continue to do so. Under Mr. Rann's leadership, deep mining had taken off so

well in South Australia, that it had helped the economy to take a positive turn. He stressed on the role Indian companies could play there, and solicited Indian companies to play a role in the mining boom in South Australia.
