from the desk of the PRESIDENT

Dear Member,



The year is turning out to be a hard and challenging one for all of us. The economy is quite fragile, business sentiments are down and even as I write the whole of North, East and North East India are recovering from the unprecedented electricity grid collapse. The RBI's efforts to infuse liquidity without reducing the interest rates and the Government's newfound alacrity in speeding up PPP projects in infrastructure development (one of the current areas of priority for the PM) are efforts to make the best out of a very difficult situation. What has sent a chill down industry's collective spine is the recent violence in the Maruti plant at Manesar.

The Bengal Chamber of Commerce and Industry very strongly condemns the industrial violence in the Manesar Plant of Maruti Udyog Limited. Such instances of violence at the workplace cannot be tolerated as it ruins the work culture and takes away from the attractiveness of India as an investment destination. Those guilty should be booked under Criminal Law and not the Industrial Disputes Act since this appears to be a pre-planned act of violence and not a genuine industrial relations problem.

However, what this also means is potential business opportunities for other States and our very own West Bengal has jumped in the fray with a proposal to Maruti to set up a plant here. While the intention is commendable, the actual chances of that happening are quite remote since Bengal still lacks critical infrastructure although work has begun in earnest towards highways development. As has been suggested by eminent leaders of industry, the Government has to provide land for basic and core infrastructure projects such as roads, ports, airports, power plants and telecom towers by making a distinction (if at all) between commercial transaction and essential infrastructure projects.

On the national front, a lot rides on the ensuing Monsoon Session of Parliament and we can only hope that days of policy inaction are behind us and that our Legislators will debate, discuss and finally pass the countless important Bills that are held up.

Your Chamber has continued to bring to you relevant programmes reflecting the needs and issues of industry. In this respect, noteworthy to mention are the annual Business-IT Conclave focusing on cyber security (and releasing the Chamber's updated guidelines on cyber security) and the upcoming Environment and Energy Conclave 2012, which has now become one of the most important national programmes dedicated to Climate Change mitigation and environmental management. This year, the Chamber will also be organizing a big-ticket programme on Digital Marketing bringing together digital marketing leaders and icons.

Keep yourself engaged with the Bengal Chamber- participate / initiate / suggest / execute in programs and activities/ interventions/advocacy.

Background

As the country is pinning its hopes on the skills development sector to solve the problem of poverty and unemployment, and at the same time is dreaming big of becoming the skills capital of the world, it better put its skills house in order. It is imperative to check whether the government and private institutes — where lakhs of young people are trained in essential trades like electrician, plumber, mechanical trades, welding, mechanic motor vehicle, voice and non-voice data processing, IT, Finance, Work Place Skills etc. — have the required infrastructure for training or not. One of the biggest concern areas, as seen above, is the availability of quality trainers and the evenness in the quality of trainers.

The need is to train and certify trainers as per industry standards. The issue of instructor training being big and complicated needs putting in place multiple solutions. The time is now and here to act and create a pool of trained instructors to meet the challenges which are knocking at our door.

As there is shortage of trainers in every field, efforts are to be made to reach all the sections by conducting effective trainers training.

Maximum outreach of quality training to students

could be done by using innovative methods.

SPECIFIC TO WEST BENGAL

West Bengal with a population of around 83 million accounts for 7.6 per cent of the country's population. The state's geographical area of 89,000 sq.kms. covers 2.7 per cent of the country's geographical area. The State has 19 districts and Calcutta is the State's capital. There are 23 towns with a population of over 100,000.

West Bengal is the fourth most populous state in India, and ranks first in terms of population density. West Bengal is predominantly an agriculture driven state, however, there has been a rich tradition of industrial setups since the start of the industrial age in India. The state is actively engaging investments in industrial sectors to ensure resurgence in of a glorified past as a leader in industrialization in India.

As per the Hon'ble Minister for Commerce and Industries, IT, Industrial Reconstruction, "West Bengal is among those very few states in India who are blessed with a vast talent pool. West Bengal does house some of the finest institutes in the country in engineering, an IIT and Jadavpur University, BESU among others. We also have the private engineering colleges under WBUT who also give the state a generous number of talent





resource. The challenge for the state is to build capacity to reduce the skill gap and also try to create opportunities so that there is a reverse brain drain in favour of the state. The government of West Bengal has

a vision of providing additional employment opportunity to at least 50,000 by 2017 and 10,0000 by 2020 in the engineering sector. We are going forward with various collaborative measures which will subsequently be implemented."

Reports show that approximately 57% of India's youth suffer some degree of unemployment, and there are over 85 million unemployable youth who urgently need skill upgradation in order to make them employable. The need of the hour, thus, is immediate skill development to fulfill West Bengal's growing need for skilled manpower across sectors, and thus narrow the rather sizeable gap between the demand and supply of skills.

Several initiatives under PPP mode formed under the supervision and support of National Skill Development Corporation (NSDC) have come up:

The Future Group has planned to open 1,680 skill development centres across the country over the next four years in association with National Skill Development Corporation (NSDC). Future Sharp Skill Ltd (FSSL) will begin rollout of the skill development centres with West Bengal. Future Sharp Skills Ltd is a joint venture company between Future Group and National Skill Development Corporation

- (NSDC). In West Bengal the company will have 40 centres in total and each would cost around Rs 20 lakh.
- The National Skill Development Corporation (NSDC), Government of India, entered into a public private partnership with Britti Prosikshan Pvt. Ltd., a group company of Technable Solutions, an acclaimed Social Enterprise, based in Kolkata. The objective of this partnership is to create skilled workforce by training over 1 lakh young men and women across West Bengal, covering all the districts, leading to their employment. As part of the agreement, NSDC will fund 75% of the project cost (Rs. 1.40 Crore) and the remaining 25% will be funded by Britti Prosikshan. Skills training and employment assistance will be provided in trade segments (industry sectors), namely, Retail, Banking, Financial Services and Insurance (BFSI); ITeS BPO, Hospitality, Travel and Tourism; Logistics, Transportation and Warehousing. The training programme will cover 300 hours of training over a span of 3 months. The comprehensive training programme will include trade specific domain skills, communication skills, soft skills and basic computer skills at a minimal cost of Rs.7500 only.
- IL&FS Education and Technology Services Ltd in collaboration with the West Bengal Government will set up a skill development centre here for IT and ITeS courses. As part of the National Skill Development Corporation's programme, IL&FS Education, a subsidiary of IL&FS India, expects to train

2,000 people a year for five years at the proposed local centre. The skill development centre is expected to be commissioned and with a mandate to ensure 75 per cent placement, IL&FS Education also plans to set up three multi-skill training centres in the State at Howrah, Durgapur and Siliguri.

Trained Manpower

Dilip Chenoy, CEO and Managing Director of NSDC, said private sector employers need value trained manpower. "There is a requirement for 347 million skilled people in the country and nearly 12.5 million trained workers enter the workforce every year," Chenoy said.

In certain sectors, the gap between the demand and supply of skilled workers was yawning. He pointed out that the job market entrants were less keen to join infrastructure and construction-related skill development courses but interested in IT and ITeS courses.

"Nearly \$1 trillion is likely to be invested in infrastructure in the 12th Five-year Plan and the industry requires 103 million skilled workers," he said.

West Bengal with a young population will need to focus on Skill development to create employment, employability and this in turn will enhance the SDP of the state and bring about a paradigm change in the economy of the state by creating sustainable livelihoods. Thus Skill development in state will usher in an era of success for the State.

The Bengal Chamber of Commerce and Industry, through its Skill Development Task Force, participated in the Australia India Skills Conference, Perth from 10th to 11th July 2012. Honourable Chris Evans, Minister for Tertiary Education, Skills, Science and Research and Honourable Peter Collier, Minister for Energy, Training and Workforce Development and Indigenous Affairs, Australia were present at the conference organised at the Central Institute of Technology, Perth, Western Australia.

As an extension of the Perth Conference, the State Government of Victoria scheduled a visit to Melbourne from 12th -13th July 2012, post the Perth event. This event was set up to have focussed meetings with the State Government of Victoria and their VET stakeholders.

The aim of the Australia India Skills Conference was to provide a platform to facilitate increased mutual understanding of the role of the two governments in Vocational Education and Training (VET) collaboration, showcase successful Australian—Indian efforts in skills with their learnings, and foster the formation of new collaborations. Sectoral focus will be on Mining, Construction, Infrastructure, Hospitality, Healthcare and Services . The programme included relevant Panel discussions, Case Studies,

Roundtable-'world cafe discussions' and site visits to industry leaders in the Australian VET. A number of MOUs were signed during the visit. Veerappa Moily, Minister of Corporate Affairs, Government of India, on 'Companies Bill and Competition Law' on Tuesday, 24th July, 2012 from 10.00 a.m. in the Chamber premises.

Mr. Sandipan Chakravortty, Immediate Past President of the Chamber welcomed the Hon'ble Dr. M. Veerappa Moily, Minister of Corporate Affairs, Government of India. Mr. B. B. Chatterjee, Chairperson, Company Affairs Committee of the Chamber delivered the theme address of the interactive session. Mr. Rakesh Singh, President, EIRC-ICAI, also welcomed the Minister. Dr. M. Veerappa Moily thanked the Bengal Chamber for inviting him and delivered his address on the proceedings of the Companies Bill, 2011. He shared his views on the Standing Committee Report to the Lok Sabha placed on 26th June 2012. He also briefly highlighted the revised Bill which was to be tabled in the ensuing Monsoon Session of the Parliament. The Hon'ble Minister discussed issues like provision respect of CSR- disclosure

spends and boundaries, tenure of independent directors, lady directors, provision in respect of rotation of auditors and for rotation of audit signing partners, competition law and companies' bill provision and NCLT.

Mr Gurcharan Das, Former MD and CEO – P&G India and currently an extremely well acclaimed Author and Public Speaker, addressed The Bengal Chamber members and select invited audience at another of our THINK sessions.

The columnist, philosopher, writer of fiction and nonfiction, and former CEO of Procter & Gamble India's presentation, "India grows at night while the government sleeps", explained why India is the second-fastest growing economy in the world despite its large and burdensome Government. Mr. Das elaborated that India is one of the most capitalist countries in the world — not because the Government wants it, but because the Government can't do anything about it. To illustrate his point, Das told the tale of two cities: Gurgaon and Faridabad. In 1979 both cities were poor, but Faridabad had the advantage of being rich in natural resources, as well as having a direct railway to the India's capital, New Delhi. Indian central

planners calculated that Faridabad would be a symbol of India's success, and spent much time and energy in attempting to grow the area. Yet surprisingly, three decades later, Gurgaon is an economic powerhouse, while Faridabad remains an impoverished area. The difference, according to Mr. Das, was that Gurgaon prospered because it had no municipal Government. Gurgaon's disadvantage — no local government — became its advantage, he elaborated.

Mr. Das also went on to elaborate on the difference between China and India. He pointed out that while China has disciplined civil servants and a strong infrastructure, the citizens there do not enjoy liberty. He contrasts this with India, which has more individual liberty but a highly inefficient bureaucracy.
