This industry-linked skill training project by such an industry major is presumed to be a landmark for business resurgence in Bengal having a cascading effect on the lives of its "Tailoring Community" comprising of 3.6 lakh poor tailors (10% of the total number of tailors in India), with the majority from the minority community. The initiative is also expected to revive the dying trade of tailoring, which has been facing decadence in the deluge of readymade garments and branded apparels across the Indian market.

A survey by the Government of India reveals that by 2020, "Tailoring" will be the biggest sector (shortage of tailors is assessed to the tune of 1.5 lakhs) after agriculture to provide job opportunities and open income generating avenues through entrepreneurship and self-help groups.

Being the second of three quintessential elements (Roti, Kaapda aur Makaan) of human life, Kaapda or Clothing and the related trade of stitching must survive with regained grandeur and sustainability, if leveraged with suitable technological interventions. More so, the demand will always be there for properly trained and qualified tailors from the new breed of fashion designers, multi brand fabric selling outlets, exporters of world class safety uniforms, etc.

Having faith and belief in this line of thinking, the three stakeholders (BCC&I, Department of Technical Education and Training, Government of West Bengal and Raymond as their part of CSR activity with 725 own outlets in line) joined hands in the setting up of two training centres (at Jnan Ch. Ghosh Polytechnic Campus, Mominpur, Kolkata and Gems Jewelry Park, at Domjur in Howrah respectively) with learning opportunity (certified under NCVT, Govt. of India) and livelihood scope to minority, underprivileged youth and women.

BCC&I has thus set a precedent in presenting a "skill based growth template".

At another interactive THINK Session organized by The Bengal Chamber along with Black Dog & The Telegraph, Mr. Rohit Ohri, Chairman, Dentsu India, spoke on "Democratization of Brands". Talking on the occasion, Mr. Ohri delved on how a Brand relates closely with its Target Audience. Elaborating, Mr. Ohri took the example of Gareth Kay, a globally renowned strategic planner at a US agency (Goodby, Silverstein & Partners), who spoke about how brands' behavior can be compared to the mating habits of birds. In particular, he

compared the genetic-hand-me-down attractiveness that peacocks rely on to attract the female of the species, versus the ingenious, custom built love nests that each of the plainer looking bower birds designs to attract the female of its species. The oversimplified takeaway: as for birds, so for brands. It's how you look, it's what you do with and for them that will

attract people to your brand.

But is it all as simple as that?

In politics, as in life, with brands, people want to feel empowered, to be partners in an ecosystem. Again, as we're seeing demonstrated in politics though, yielding complete control to consumers might just result in brand anarchy. The trick is to figure out how to give enough slack to the reins



course of the brand, letting consumers power it. Tough? One can bet it is!!!!! In the participation economy, people don't want to merely buy your brand. They want to buy *into* the brand.

IIMC had authored a case study about multinational Global In-house Centres (GICs) with a focus on the transformation at Microsoft India. The Case Report was released in Kolkata on this occasion. The Bengal Chamber hosted the programme.

The GICs that began by doing back-office operations have moved a long way to become key players in the global design and growth of the company. GICs have matured over these years. They have built expertise; have developed leadership and credibility that are integrated with the parent company. More important, the median age of GICs in India is 8 to 10 years and they have moved from execution centres to expertise centres.



The Bengal Chamber, in association with Black Dog and The Telegraph, presented another THINK Session on Feb 21, 2014. Dr. Aftab Seth, a retired diplomat and former ambassador to Japan, spoke about the oddities of India- Japan relations at this Think Session.

Japan has the third highest GDP in the world at about US \$ 4.4 trillion. That's four times more than India's. It has a population of 128 million that enjoys a per capita income of \$ 37,000. That's 37 times more than India's. It is pollution- free, chooses not to raise an army and has a delicate sense of design and

aesthetics. It also has a brutal World War II history.

Cold statistics give a glimpse of the gap between India the elephant and Japan the derby horse, but the odd couple had ticked despite occasional hiccups. The Rhodes scholar with a PhD from Greece harked back to events that unfolded 1,500 years ago when Indian thoughts and Buddhism gained roots in Japan. Cutting back to modern times, he said: "Tagore visited the country five times and Swami Vivekananda travelled to Japan on his way to Chicago. Rashbehari Bose, accused of trying to kill Lord Hardinge, was given refuge in Japan and Subhas Chandra Bose's INA was assisted by a group of young soldiers from Japan. At the International Military Tribunal, Justice Radhabinod Pal gave his dissenting judgment in favour of Japan. The Boses and Pal are revered at the Yasukuni shrine in Tokyo." Seth showed how the foundations were reinforced when India helped Japan with iron ore to rebuild its steel industry after the crippling World War.

Japan returned the favour. India was the first country to receive the Japanese Overseas Development Aid (ODA) after the Korean conflict. The Cold War distanced the two friends for a while, but "during the worst forex crisis of

India, Prime Minister Hashimoto bailed India out with a loan", Seth said. India's May 1998 nuclear test at Pokhran ruffled Japanese feathers, though." They felt we let them down and they cut all fresh ODA to us." When the boat was rocking post- Pokhran, a band of Indonesian pirates rubbed the frost off the Indo- Japan ties. Indian navy rescued the Japanese crew, left adrift in the high seas in a lifeboat without food or water, after the pirates hijacked their ship.

Soon after, then Finance Minister, Jaswant Singh was invited to Japan in November 1999. "Close on the heels came (Bill) Clinton's five- day love fest in India and four months later Yoshiro Mori came and announced global partnership for the 21st century with (Atal Bihari) Vajpayee. This was a comprehensive security dialogue between India and Japan," Seth said.

"It was Osama Suzuki who came to India in the '80s even before the economic liberalization and, in a leap of faith, set up shop with a public sector company, thus forming Maruti Suzuki India Ltd. This was pioneering coming at a time when it did," he added.

Signing off, the former Ambassador hoped that the recent visits of Emperor Akihito and Queen Michiko and Prime Minister Shinzo Abe would bolster ties between the two countries. He said that Indo- Japan ties were like a kite's string, invisible in the sky but visible on the finger.

Mr. P Roy, Director General of the Chamber, while speaking about the yeoman services of the Bengal Chamber, also highlighted the services BCC&I has been rendering almost since inception in the matter of alternative dispute resolution (ADR) to the business and trading community with respect to their dealings

and transactions. ADR Services of the Bengal Chamber were relaunched during the national conference on "Proposed Amendments to the Arbitration and Conciliation Act, 1996 and ADR" held in April 2011. The rules of Arbitration, Conciliation and Mediation have been framed and uploaded on the website of the Bengal Chamber. Mr. Roy further referred to the Chamber's panel of

arbitrators comprising competent, reputed, established and experienced personnel from all professions including legal luminaries, i.e., retired judges of Supreme Court and High Court.

Participating MSMEs, represented by their owners / senior management, deliberated mainly on the difficulties in availing loans from the bankers without co-laterals and inadequacy and delay in sanctioning project loans. Members pointed out that co-laterals are not required for MSMEs for loans up to Rs. 1 crore and requested SBI's intervention to sanction loan expeditiously. The representatives of the banks elaborated that their function essentially was risk management and also to support the MSME Sector's growth. However, their activities were governed by the regulators and they would always have to act within the purview of the guidelines especially in view of increasing NPAs. They however, assured that SBI would not spare any efforts to accommodate the needs of the MSMEs. For any project finance, pointed out by the bankers, proposals need to be evaluated by the appropriate rating agency with the feasibility report. MSMEs were requested to co-ordinate with the relevant State Bank branches in their areas and could always approach SBI personnel attending the seminar for help and assistance. The meeting concluded with a Vote of Thanks by the Director General, BCC&I.
